On 5 April 2022 the Company announced a non-renounceable pro rata Rights Issue eligible investors on the basis of one new share for every five shares held as at the record date at the same price as the placement, being \$0.10 per Share. The Company is seeking to raise a total of \$2.3 million (before costs) from the Rights Issue.
